



The Truth about Chlorine Dioxide and Big Pharma & Partners

Fact #1

Chlorine Dioxide is a chemical compound with the formula $ClO_2 - 1$ Chlorine and 2 Oxygen atoms. It exists as a greenish-yellow gas above 11° C, as a reddish-brown liquid between -59° C and 11° C, and as bright orange crystals when colder. It does not hydrolyze when it enters water, and it is usually produced as a gas or as an aqueous solution. The British chemist Sir Humphry Davy discovered it in 1814.

Fact #2

Chlorine Dioxide has been used extensively for bleaching wood pulp (in the paper industry) and for disinfecting water (for human consumption) in Europe and the US. Developments since the 1930s have extended its application into food processing, equipment and premise disinfection, mold eradication, pool treatment, wastewater sanitation, air sterilization and odor control, wound cleansing, dental and oral care, and – a great discovery for mankind – disease prevention and treatment.

Fact #3

Chlorine Dioxide is the active ingredient in Master Mineral Solution (MMS) and Chlorine Dioxide Solution (CDS) – which have been used for the prevention and treatment of a wide range of diseases, including malaria, arthritis, cancer, autism, diabetes, hepatitis, Alzheimer's, influenza, herpes, MRSA, AIDS, EVD, and COVID. 
Fact #5

Make 28% Master Mineral Solution (MMS)

Things Needed

- 1. Sodium Chlorite (NaClO₂) powder or flakes (80% purity, technical grade) 2. Sodium Chlorite solution (any strength above 22.4%, technical grade)
- 3. distilled (best), reverse osmosis, or purified water (not alkaline or tap water)
- 4. nonmetallic utensils and containers (eg, spoon, bowl, measuring cup, and bottle)
- 5. digital kitchen scale with a tare feature; unbleached (best) or white coffee filter

For items 1 and 2, buy either Sodium Chlorite powder or Sodium Chlorite solution from pool supplies stores or chemical suppliers. The powder (or flakes) typically consists of 80% Sodium Chlorite and about 17% Sodium Chloride, 1% Sodium Chlorate, and 2% of other trace compounds. This stabilized mixture, which contains added buffer and only 80% Sodium Chlorite, is safe for handling and storage. It will benefit all citizens if nationwide pharmacies can sell Sodium Chlorite powder (at a government-controlled price) with detailed instructions on how to make 28% MMS.

How to Make 28% MMS

28% Master Mineral Solution (MMS) is in fact 22.4% Sodium Chlorite Solution (SCS), because only 80% of the dissolved compounds (ie, the Sodium Chlorite powder) in 28% MMS are Sodium Chlorite: 80% x 28% MMS = 22.4% SCS

Method 1: Using Sodium Chlorite powder

Dissolve 1 part by weight of Sodium Chlorite powder in $[18 \div 7]$ parts by weight of water.

Example:

Dissolve 140 g of Sodium Chlorite powder in 360 g (ie, 140 g x [18 \div 7]) of water.

Let the solution stand for 24 hours in a dark place, then optionally filter it with an unbleached coffee filter. Store the MMS in a bottle (made of tinted glass, HDPE, or PP), away from heat and direct sunlight. Label the bottle as 28% MMS or 22.4% SCS. It can be kept in the refrigerator for extended shelf life.

Method 2: Using Higher-strength Sodium Chlorite Solution (SCS)

Dilute higher-strength SCS (ie, any strength above 22.4%) with this formula:

The amount of water required to dilute V mL of higher-strength SCS = [(Higher strength
$$\div$$
 Desired strength) $-$ 1] x V mL

Example:

Higher strength = 28%; Desired strength = 22.4%; V mL = 400 mL

The amount of water required to dilute 400 mL =
$$[(28\% \div 22.4\%) - 1] \times 400$$
 mL = 100 mL of 28% SCS

Mix 400 mL of 28% SCS with 100 mL of water to obtain 500 mL of 22.4% SCS. Store the SCS in a bottle (made of tinted glass, HDPE, or PP), away from heat and direct sunlight. Label the bottle as 22.4% SCS or 28% MMS. It can be kept in the refrigerator for extended shelf life.

Make 25% Sodium Chlorite Solution (SCS)

Things Needed

- 1. Sodium Chlorite (NaClO₂) powder or flakes (80% purity, technical grade) 2. Sodium Chlorite solution (any strength above 25%, technical grade)
- 3. distilled (best), reverse osmosis, or purified water (not alkaline or tap water)
- 4. nonmetallic utensils and containers (eg, spoon, bowl, measuring cup, and bottle)
- 5. digital kitchen scale with a tare feature; unbleached (best) or white coffee filter

For items 1 and 2, buy either Sodium Chlorite powder or Sodium Chlorite solution from pool supplies stores or chemical suppliers. The powder (or flakes) typically consists of 80% Sodium Chlorite and about 17% Sodium Chloride, 1% Sodium Chlorate, and 2% of other trace compounds. This stabilized mixture, which contains added buffer and only 80% Sodium Chlorite, is safe for handling and storage. It will benefit all citizens if nationwide pharmacies can sell Sodium Chlorite powder (at a government-controlled price) with detailed instructions on how to make 25% SCS.

How to Make 25% SCS

25% Sodium Chlorite Solution (SCS) contains more Sodium Chlorite than 28% Master Mineral Solution (MMS), because 28% MMS is in fact 22.4% SCS. 28% MMS or 22.4% SCS is the original formula developed by Hon. Jim Humble. 25% SCS is the formula preferred by Hon. Andreas Kalcker.

Method 1: Using Sodium Chlorite powder

Dissolve 1 part by weight of Sodium Chlorite powder in 2.2 parts by weight of water.

Example:

Dissolve 150 g of Sodium Chlorite powder in 330 g (ie, 150 g x 2.2) of water.

Let the solution stand for 24 hours in a dark place, then optionally filter it with an unbleached coffee filter. Store the SCS in a bottle (made of tinted glass, HDPE, or PP), away from heat and direct sunlight. Label the bottle as 25% SCS. It can be kept in the refrigerator for extended shelf life.

Method 2: Using Higher-strength Sodium Chlorite Solution (SCS)

Dilute higher-strength SCS (ie, any strength above 25%) with this formula:

Example:

Higher strength = 30%; Desired strength = 25%; V mL = 400 mL

The amount of water required to dilute 400 mL =
$$[(30\% \div 25\%) - 1] \times 400$$
 mL = 80 mL of 30% SCS

Mix 400 mL of 30% SCS with 80 mL of water to obtain 480 mL of 25% SCS. Store the SCS in a bottle (made of tinted glass, HDPE, or PP), away from heat and direct sunlight. Label the bottle as 25% SCS. It can be kept in the refrigerator for extended shelf life.

Make 4% Hydrochloric Acid Solution (HAS)

Things Needed

- 1. Hydrochloric Acid (HCl) solution (above 4%, no additives, technical or lab grade)
- 2. distilled (best), reversé osmosis, or purified water (not alkaline or tap water)
- 3. nonmetallic utensils and containers (eg, spoon, bowl, measuring cup, and bottle)
- 4. odor-blocking mask and plastic gloves

How to Make 4% HAS

Dilute higher-strength HAS (ie, any strength above 4%) with this formula:

Example:

Higher strength = 20%; Desired strength = 4%; V mL = 100 mL

The amount of water required to dilute 100 mL =
$$[(20\% \div 4\%) - 1] \times 100$$
 mL = 400 mL of 20% HAS

Mix 100 mL of 20% HAS with 400 mL of water to obtain 500 mL of 4% HAS. Store the HAS in a bottle (made of tinted glass, HDPE, or PP), away from heat and direct sunlight. Label the bottle as 4% HAS.

Make 50% Citric Acid Solution (CAS)

Things Needed

- 1. Citric Acid ($C_6H_8O_7$) powder or crystals (99% purity, food or lab grade) 2. distilled (best), reverse osmosis, or purified water (not alkaline or tap water)
- 3. nonmetallic utensils and containers (eg, spoon, bowl, measuring cup, and bottle)
- 4. digital kitchen scale with a tare feature

How to Make 50% CAS

Dissolve 1 part by weight of Citric Acid powder in 1 part by weight of water.

Example:


Dissolve 300 g of Citric Acid powder in 300 g (ie, 300 g \times 1) of water. The solution will temporarily turn cold. Store the CAS in a bottle (made of tinted glass, HDPE, or PP), away from heat and direct sunlight. Label the bottle as 50% CAS.

4% HAS vs 50% CAS for Activating 28% MMS and 25% SCS


Buy either higher-strength HAS or Citric Acid powder (or buy both) from hardware stores, grocery stores, or chemical suppliers. Either the 4% HAS or the 50% CAS can be used to activate the 28% MMS and the 25% SCS. The 4% HAS is preferred by some people due to better taste or better tolerance of the stomach, especially when the ingestion of activated MMS or SCS is required. However, some other people prefer the 50% CAS, especially when the aforementioned ingestion is not required. Citric Acid powder is also sometimes more readily available and easier to transport.

Make 3,000-ppm Chlorine Dioxide Solution (CDS)


Method A: Double Infusion at Room Temperature (21–25° C) Using Sodium Chlorite Solution (SCS) and Hydrochloric Acid Solution (HAS)



Leave the container for 12 hours in a dark place, followed by 2 hours in the refrigerator.




Replace the reaction solution with 5 mL of 25% SCS and 5 mL of 4% HAS.



Leave the container for 12 hours in a dark place, followed by 2 hours in the refrigerator.


The color of the reaction solution is the same as the color of the CDS.




Store the CDS in a bottle. Label the bottle and keep it in the refrigerator.

Method B: Single Infusion at Room Temperature (21–25° C) Using Sodium Chlorite Solution (SCS) and Citric Acid Solution (CAS)

Leave the container for 12 hours in a dark place, followed by 2 hours in the refrigerator.



The color of the reaction solution is the same as the color of the CDS.



Store the CDS in a bottle.


Label the bottle and keep it in the refrigerator.

Method C: Single Infusion at Refrigerator Temperature (3–7° C) Using Master Mineral Solution (MMS) and HAS or CAS

Leave the container for 36–60 hours in the refrigerator. Airtight lid Glass/ HDPE/PP-240 mL container of distilled or purified Shot water glass 12 mL of 28% MMS and Label the bottle and 12 mL of 4% HAS or 50% CAS keep it in the refrigerator. 1

The color of the reaction solution is the same as the color of the CDS.




Use container and bottle made of glass (best), HDPE, or PP. Avoid inhaling any escaped Chlorine Dioxide gas during the process. Accidental inhalation in small amount is harmless. For methods A and B, if the room temperature is below 21° C, leave the container for up to 24 hours in a dark place, followed by 2 hours in the refrigerator.

Test the Concentration of 3,000-ppm CDS LaMotte Insta-Test Chlorine Dioxide InstaTest ANALYTIC Test Strip, Code 3002, High Range 100 250 500 0-500-ppm Range Chlorine Dioxide 10 25 50 (L 4% NaClo² 25% Citric Acid 50%

Method A: Add 1 mL of the CDS to 59 mL of water. Dip the test strip in the Dilute CDS for 2 seconds, then remove it with its pad facing up. Do not shake off any excess liquid. Wait for 10 seconds, then compare the pad's color against the color chart. If the CDS's concentration is 3,000 ppm, the pad's color will match the chart's 50-ppm color. If the CDS's concentration is slightly higher than 3,000 ppm, the pad's color will be in between the chart's 50-ppm and 100-ppm colors, nearer to the former.

Method B: Add 10 mL of the CDS to 90 mL of water. Follow the dipping and comparing steps in Method A. If the CDS's concentration is 3,000 ppm or slightly higher, the pad's color will be in between the chart's 250-ppm and 500-ppm colors, nearer to the former.

CDS Protocols for Viral Outbreak and Disease



Protocol C (Common) - Preventing Infection and Treating Chronic Disease

Add 10 mL of 3,000-ppm CDS to 1 L of water in a bottle – to make Dilute CDS (\approx 30 ppm). Drink 100 mL (ie, \approx one-tenth) of the Dilute CDS every hour, 10 times a day. This is equivalent to taking a CDS dose of \approx 1 mL every hour – for people of 60 kg and above. If one has been in close contact with an infected person, take a higher dose of 1.5 mL. Add 15 mL of CDS to 1 L of water in a bottle (\approx 45 ppm) to obtain an hourly dose of \approx 1.5 mL. The health care personnel who take care of infected patients may require a much higher dose of 2–3 mL, especially if they are at an altitude of 2,600 m and higher.

For body weight of under 60 kg, use 2 or 3 mL of CDS for each 12 kg. Dilute the CDS with 100 or 66.6 times of water, respectively. For example, a 24-kg child requires 4 mL (ie, $[24 \div 12] \times 2$ mL) of CDS. Add 4 mL of CDS to 400 mL (ie, 4 mL x 100) of water in a bottle (\approx 30 ppm). Drink 40 mL (ie, \approx one-tenth) of the Dilute CDS every hour, 10 times a day. If the child has been in close contact with an infected person, take a higher dose. Add 6 mL (ie, $[24 \div 12] \times 3$ mL) of CDS to 400 mL (ie, 6 mL x 66.6) of water in a bottle (\approx 45 ppm) to obtain a higher hourly dose.

There was a clinical trial in South America that used Dilute CDS to treat COVID-19 – all the mildly-to-critically ill patients recovered. The usual oral dosage prescribed in the trial was ≈ 1.67 mL of 3,000-ppm CDS an hour, 10 times a day.

In the case of treating chronic illnesses or diseases, increase the hourly dose slowly. Depending on how one feels, build up the dose slowly to 3 mL (for people of 60 kg and above). Add up to a maximum of 30 mL of CDS to 1 L of water. If a higher dose (ie, 4–6 mL of CDS) is necessary, prepare enough of the Dilute CDS for more intake (ie, 200 mL of Dilute CDS) each hour.

Do not take more than 5 mL an hour for each 100 kg of body weight (or more than 60 mL a day). For example, if one weighs 60 kg, do not take more than 3 mL (ie, $[60 \div 100] \times 5$ mL) an hour. A 24-kg child should not take more than 1.2 mL (ie, $[24 \div 100] \times 5$ mL) an hour. If there is a mild throat irritation after taking the dose (which is brief and harmless), optionally dilute the daily dose with more water. In case of nausea or discomfort, reduce the dose by 50% until the reaction goes away.

Follow the Three Golden Rules of MMS:

- 1. Feeling better?
 - Do not change anything. Continue with what you are doing.
- 2. Feeling worse?
 - Reduce the dose by 50% until the reaction goes away, then build back up slowly.
- 3. Not feeling better or not feeling worse?

 If there are no signs of improvement after 5–6 days, increase the dose or switch to another protocol.

Antioxidants – especially Vitamin C or Ascorbic Acid – can easily neutralize Chlorine Dioxide. Throughout the treatment period, avoid antioxidant supplements and high-antioxidant foods and drinks (eg, orange or citrus fruits, mango, pineapple, kiwifruit, berries, chocolate, tea, milk, coffee, alcohol, and fruit juices). If one needs to take meal or medicine, observe an interval of 1 hour. This protocol can be administered for the treatment of most chronic illnesses or diseases. It is also suitable for the regular detoxification or cleansing of the body. The treatment can be for as long as it is necessary until one feels fully recovered.

Protocol F (Frequent) - Treating Mild-to-Severe Infection or Symptoms

Add 10 mL of 3,000-ppm CDS to 500 mL of water in a bottle – to make Dilute CDS (\approx 60 ppm). Drink 63 mL (ie, \approx one-eighth) of the Dilute CDS every 15 minutes, 8 times a session (of 1¾ hours) – for people of 60 kg and above with mild symptoms. Use 15 mL of CDS if one has *fmss* (ie, a fever or moderate-to-severe symptoms). Use 20 mL of CDS if one has *fmss*, and has \leq 92% oxygen saturation or is at an altitude of 2,600–3,600 m. Use 30 mL of CDS if one has *fmss*, and has \leq 85% oxygen saturation or is at an altitude > 3,600 m. When using 15, 20, or 30 mL of CDS, dilute the CDS with 500, 750, or 1,000 mL of water, respectively.

For body weight of under 60 kg, use 2, 3, 4, or 6 mL of CDS for each 12 kg. Dilute the CDS with 50, 33.3, 37.5, or 33.3 times of water, respectively. For example, a 24-kg child who has *fmss* requires 6 mL (ie, $[24 \div 12] \times 3$ mL) of CDS. Add 6 mL of CDS to 200 mL (ie, 6 mL x 33.3) of water in a bottle (\approx 88 ppm). Drink 25 mL (ie, \approx one-eighth) of the Dilute CDS every 15 minutes, 8 times a session. Use 4 mL of CDS if the child has *fmss*, and has \leq 92% oxygen saturation or is at an altitude of 2,600–3,600 m. Use 6 mL of CDS if the child has *fmss*, and has \leq 85% oxygen saturation or is at an altitude > 3,600 m. Administer this protocol once/twice a day:

Once Administer it in the morning, followed by Protocol C after a 2–3-hour break a day: (for mild-to-severe symptoms: runny nose, sore throat, chills, body aches, fatigue, dry cough, fever, shortness of breath, vomiting, dizziness, etc). Twice Administer it in the morning and afternoon, with a 2–3-hour break in a day: between sessions (for severe symptoms: fever, shortness of breath, etc).

Do not take meal or medicine from one hour before to one hour after the session. Follow the dietary restrictions of Protocol C and the Three Golden Rules of MMS.

Protocol Y (Yellow Infusion) – Treating Critical Infection or Symptoms

Add 5–50 mL of 3,000-ppm CDI (Chlorine Dioxide Infusion: CDS made with 0.9% saline) to 500 mL of 0.9% saline in an infusion bag – to make saline Dilute CDS. Use a digital pH meter to ensure that the pH of the saline Dilute CDS is 7.4–7.8 to avoid phlebitis. Buffer its acidity with Sodium Bicarbonate if necessary. Use it for intravenous (IV) infusion. The typical schedule is 3–4 consecutive days of infusion.

Example for a 60-kg patient who is not on a ventilator (at an altitude < 2,600 m): Using 5 mL of CDI: 505 mL of \approx 30-ppm saline Dilute CDS, 3–4 hours of infusion – followed by Protocol C after a 2–3-hour break.

Example for a 60-kg patient who is on a ventilator (at an altitude < 2,600 m): Using 10 mL of CDI: 510 mL of \approx 60-ppm saline Dilute CDS, 7–8 hours of infusion.

Cover the infusion bag with a dark covering (eg, a black plastic bag) to protect the saline Dilute CDS from ultraviolet (UV) light. If the patient has \leq 85% oxygen saturation and is at an altitude of 2,600–3,600 m, use 20 mL of CDI. If the oxygen saturation is \leq 75% and the altitude is > 3,600 m, use 30 mL of CDI. In the case of near-death patients at home and of patients with morbid obesity, use 50 mL of CDI. The drip rate should be slow at 15 drops (or less) a minute to avoid phlebitis.

This protocol must be administered under the supervision of a physician or a health care professional. Follow the dietary restrictions of Protocol C. For more details on this protocol, consult the physicians at COMUSAV (World Health and Life Coalition), who have already treated over 100,000 COVID-19 patients successfully with Dilute CDS. Watch video 41 (Scientific Efficiency of ClO_2) in Appendix Q.

Protocol E (Enema) - Treating Severe-to-Critical Infection or Symptoms

Add 10 mL of 3,000-ppm CDI (Chlorine Dioxide Infusion: CDS made with 0.9% saline) to 500 mL of 0.9% saline in an infusion bag – to make saline Dilute CDS (\approx 60 ppm) for patients of 60 kg and above. Connect a nasogastric tube to the infusion bag. Lay the patient in a position to receive the enema (ie, the saline Dilute CDS). Gently insert the nasogastric tube into the rectum as deeply as possible until the beginning of the descending colon. Slowly squeeze the infusion bag until it is empty, then remove the nasogastric tube.

This is not an evacuation enema but a retention one. The retention of the saline Dilute CDS inside the descending colon facilitates the absorption of Chlorine Dioxide into the bloodstream. The recommended retention time is between 3 and 5 minutes. Depending on the severity of the symptoms and the altitude, 20 or 30 mL of CDI can be used with 750 or 1,000 mL of 0.9% saline, respectively.

This protocol must be administered under the supervision of a physician or a health care professional. Follow the dietary restrictions of Protocol C. For more details on this protocol, consult the physicians at COMUSAV (World Health and Life Coalition).

Protocol D (Dermatological) - Disinfecting the Skin and Objects

Add 30 mL of 3,000-ppm CDS to 60 mL of water in a spray bottle – to make Dilute CDS (\approx 1,000 ppm). Spray the Dilute CDS at the desired area on the body (eg, face, neck, and hands) or on objects.

Protocol N (Nasal) - Disinfecting the Nose and Mouth

Add 5 mL of 3,000-ppm CDS to 100 mL of water in a nasal-wash bottle – to make Dilute CDS (\approx 143 ppm). Wash the nasal cavities and gargle with the Dilute CDS. This decreases the viral load in the nose and mouth. This protocol is recommended for the health care personnel who work in the Intensive Care Unit (ICU).

Protocol O (Ophthalmological) – Disinfecting the Eyes

Add 2–3 mL of 3,000-ppm CDS to 150 mL of water (or 0.9% saline) in an ophthalmological dropper bottle (made of HDPE, PE, or PP) – to make Dilute CDS (\approx 40–60 ppm). Put a few drops of the Dilute CDS in each eye.

Protocol H (Hospital/House) – Preventing Transmission

Put 10 mL of 3,000-ppm CDS in a glass. Place the glass on a table inside a room. The evaporated Chlorine Dioxide gas disinfects the environment, preventing the transmission between patients and health care personnel. When the 10 mL of CDS (for a 10-m² area) in the glass becomes colorless, replace it with the same amount.

Protocols for Other Purposes

There are other protocols that use 3,000-ppm CDS – and the activated drops of 28% MMS and 25% SCS – for the health care of not only humans but also animals. The informative books and official websites of the honorable researchers Hon. Jim Humble and Hon. Andreas Kalcker are highly recommended.

Maintain a Strong Immune System

A weak immune system is unable to fend off pathogenic microbes, toxins, or heavy metals. The actions below are recommended to maintain a strong immune system.

1. Maintain good nutrition by having an adequate daily intake of essential nutrients: carbohydrate, protein, fat, vitamins, minerals, phytochemicals, fiber, and water.

Determine one's ideal body weight that corresponds with a Body Mass Index (BMI) of 20–23 kg/m² for both men and women, aged 18 and above. Next, determine the Daily Caloric Intake (DCI) required for maintaining the ideal body weight.

1 g of carbohydrate or protein provides 4 calories; 1 g of fat provides 9 calories. Obtain 70–80% of DCI from carbohydrate, 10–15% of DCI from protein, and 10–15% of DCI from fat. Limit or avoid trans fats, saturated fats, and cholesterol. Maximize the intake of essential fatty acids Omega-6 Linoleic Acid (LA) and Omega-3 Alpha-Linolenic Acid (ALA) in the ratio of 2–4 (LA) to 1 (ALA), respectively.

Consume unprocessed or minimally processed foods and drinks (preferably organic) whenever possible. They contain more nutrients (which are naturally occurring) than refined or heavily processed foods and drinks (which typically contain added salt, sweeteners, flavorings, colorings, preservatives, or other food additives that are potentially harmful). Limit or avoid Genetically Modified Organism (GMO) food products. Chew food thoroughly until it turns into a liquid mush to aid digestion.

Consume fermented foods (preferably homemade) that contain good bacteria. The bacteria, like the good ones in the gut, aid digestion and produce certain vitamins, including Vitamin B12. Well-planned diets, including vegetarian and vegan diets that incorporate a variety of fruits and vegetables, have no need of dietary supplements.

Limit caffeinated drinks (eg, coffee and tea). Do not drink alcohol or smoke tobacco. Drink half the body weight in fluid ounces of water a day. For example, if one weighs 134 lb, drink 67 fl oz (ie, $134 \div 2$ fl oz) of water a day. Regular table salt has about 40% Sodium. Add $\frac{1}{8}$ - $\frac{1}{4}$ level tsp of unrefined salt (ie, the trace mineral-rich sea salt that has only 32–36% Sodium and no food additives) to each 1 L of drinking water.

Do not consume more than 2,100 mg of Sodium a day for each 100 kg of ideal body weight. For example, if one weighs 60 kg, do not consume more than 1,260 mg (ie, $[60 \div 100] \times 2,100$ mg) of Sodium a day. Ensure that the daily Potassium intake is 2–4 times that of Sodium. Limit the daily Calcium intake to 1 g for each 100 kg of ideal body weight. The daily Magnesium intake should be $\frac{1}{2}$ –1 times that of Calcium.

- **2.** Do aerobic exercise for 30–60 minutes, 1–2 times a week. Add some stretching and strength-training (or weight-bearing) exercises. Follow the Three S's of Fitness (ie, the three basic principles of overall fitness): Stamina, Strength, and Suppleness.
- **3.** Rest sufficiently every night with 7–9 hours of sound sleep. Eat a light dinner and let the stomach be empty before going to bed by 11 o'clock at the latest.
- **4.** Synthesize natural Vitamin D by exposing the skin as much as possible to high-intensity (90%) sunlight for 10–20 minutes, or to moderate-intensity (60%) sunlight for 30–40 minutes, 1–2 times a week. Do not use sunscreen. Depending on the occurrence of sunburn, reduce or increase the duration of the exposure.
- **5.** Reduce stress and anxiety with hobbies (eg, watching shows, playing games, and reading books), exercises (eg, dancing, kickboxing, and tai chi), social interaction (eg, text messaging and physical chat), meditation (eg, positive-thinking, gratitude, and breathing meditation), religious study (eg, the study of the sacred texts, beliefs, and practices of one's religion), or other enjoyable stress-relieving activities.

- Chlorine Dioxide has been used to purify water for more than 70 years.

The toxicity of a substance is defined by its amount that makes it toxic, the place where it affects, its concentration, and the duration of the exposure to it.

We can read articles online, especially the disinformation articles created by the detractors of Chlorine Dioxide treatments [ie, Big Pharma & Partners], stating that Chlorine Dioxide is a toxic gas and a very strong oxidant used for the bleaching of raw textiles and wood pulp. There is certainly generic documentation that indicates this. However, when we look at it in detail, we can see that the amount used is not even close to those described in my book [ie, the book *Forbidden Health: Incurable Was Yesterday*]. The aqueous solution of Chlorine Dioxide used for the bleaching of raw textiles and wood pulp is highly concentrated with added Methanol. The concentration used is 11 g per liter (!) in conjunction with 138 g per liter (a total of 149 grams!) of Sodium Chlorate (NaClO₃), which is a much more aggressive and harmful oxidant. (Source: Georgia Institute of Technology)

The concentrations for the treatments described in my book do not usually exceed 0.003 g. If we speak of using Chlorine Dioxide as a bleach in applications, we are comparing with a solution that is 59,600 times more concentrated. Furthermore, the solution has a much stronger chemical composition, primarily due to Sodium Chlorate. We have to recognize that these false claims look good in the sensationalist media, to create controversy. However, these applications are far from the reality described in my book.

Facts and Figures

- 1. Chlorine Dioxide is not a toxin that accumulates in the body.
- 2. In 100 years of use, there are only five documented cases of poisoning [due to the ingestion of Sodium Chlorite, the precursor of Chlorine Dioxide], where all of them survived with doses hundred times higher than recommended in my book.
- 3. If you breathe air that contains an amount of Chlorine Dioxide gas, you may experience irritation in the throat, nose, or lungs.
- 4. If it is too concentrated, it causes eye irritation that is reversible.
- 5. According to the data obtained to date and its extensive use for more than 100 years, Chlorine Dioxide can be considered not to cause cancer. That is, it is not carcinogenic.
- 6. There is also no evidence of harmful toxicity in terms of reproduction.

The toxicity of Chlorine Dioxide is true in the case of inhalation, which is not the same as ingestion. In the case of inhalation of air that contains a large amount of Chlorine Dioxide gas, you will experience irritation in your throat, nose, or lungs. If it is too concentrated, it causes reversible irritation in the eyes. Ingestion is not considered toxic, depending on the dose. Of course, inhalation of the gas is toxic during prolonged exposure.

Toxicity is always dependent on the amount, so if you ingest a large concentrated amount, you will experience irritations, even severe ones; but no volunteers mentioned in my book, who followed the treatments, were exposed to amounts that are large enough to be permanently harmful to the body. There is no scientifically documented fatal case of Chlorine Dioxide poisoning in the scientific literature. It probably induces vomiting long before a critical amount is reached by ingestion.

Clinical Study of Chlorine Dioxide

A publication in 1982 revealed that a placebo-controlled and double-blind clinical study had been undertaken under the auspices of the US Environmental Protection Agency (EPA). The study demonstrated that it is relatively safe to ingest Chlorine Dioxide and its metabolites, Chlorite and Chlorate. Controlled Clinical Evaluations of Chlorine Dioxide, Chlorite and Chlorate in Man (by Judith R. Lubbers, Sudha Chauan, Joseph R. Bianchine)

To assess the relative safety of chronically administered chlorine water disinfectants in man, a controlled study was undertaken. The clinical evaluation was conducted in the three phases common to investigational drug studies. Phase I, a rising dose tolerance investigation, examined the acute effects of progressively increasing single doses of chlorine disinfectants [up to 24 mg/L for Chlorine Dioxide to normal healthy adult male volunteers. Phase II considered the impact on normal subjects of daily ingestion of the disinfectants at a concentration of 5 mg/L for twelve consecutive weeks. Persons with a low level of glucose-6phosphate dehydrogenase may be expected to be especially susceptible to oxidative stress; therefore, in Phase III, chlorite at a concentration of 5 mg/L was administered daily for twelve consecutive weeks to a small group of potentially at-risk glucose-6-phosphate dehydrogenase-deficient subjects. Physiological impact was assessed by evaluation of a battery of qualitative and quantitative tests. The three phases of this controlled double-blind clinical evaluation of chlorine dioxide and its potential metabolites in human male volunteer subjects were completed uneventfully. There were no obvious undesirable clinical sequelae noted by any of the participating subjects or by the observing medical team. In several cases, statistically significant trends in certain biochemical or physiological parameters were associated with treatment; however, none of these trends was judged to have physiological **consequence.** One cannot rule out the possibility that, over a longer treatment period, these trends might indeed achieve proportions of clinical importance. However, by the absence of detrimental physiological responses within the limits of the study, the relative safety of oral ingestion of chlorine dioxide and its metabolites, chlorite and chlorate, was demonstrated. ...

The careful clinical evaluation of every subject in Phases I, II and III failed to reveal any clinically important impact upon the medical well-being of any subject as a result of disinfectant ingestion. ...

During the course of the three-phase study, a massive volume of raw data was acquired. Routine urinalyses were performed and a meticulous examination of this body of information was made. No definitive finding of detrimental physiological impact was made in any of the three phases of this human investigation of the relative safety and tolerance of oral chlorine disinfectant ingestion. In several cases, statistically significant trends were associated with treatment; however, none of these trends was judged to have immediate physiological consequence. One cannot rule out the possibility that, over a longer treatment period, these trends might indeed achieve proportions of clinical importance. However, within the limits of the study, the relative safety of oral ingestion of chlorine dioxide and its metabolites, chlorite and chlorate, was demonstrated by the absence of detrimental physiological response. ...

Treaties on Chlorine Dioxide

Human Rights - International Treaties on Chlorine Dioxide

- Human Right to Information
- Human Right to Health

The Inter-American Court of Human Rights has ordered all the member countries of the Inter-American Commission on Human Rights that, if there is any internal rule that goes against human rights or any international treaty that protects human rights, the country must disregard that rule.

The Declaration of Helsinki (with the status of an international treaty) of the World Medical Association, in its fourth article, states, "It is the duty of the physician to promote and safeguard the health, well-being, and rights of patients, including those who are involved in medical research. The physician's knowledge and conscience are dedicated to the fulfilment of this duty." In the seventh article, it states, "Medical research is subject to ethical standards that promote and ensure respect for all human subjects and protect their health and rights." In the ninth article, it deals with the right to self-determination.

The UN Economic and Social Council states that the obligations to protect influence the adoption of laws or other measures, to ensure the quality of health care services and to ensure that physicians and other health professionals have expertise.

- If a physician applies Chlorine Dioxide at the request of a patient and is dismissed from his or her job for that reason, it is illegal. The will of the duly informed patient is above all.
- If a physician abandons a patient by refusing to use Chlorine Dioxide and the patient dies, he or she will be held liable, both civilly and criminally, for medical malpractice. In the event that family members require such treatment, they should do so in writing and, in case of refusal, should file a complaint with the medical director or supervisor. And if there is no affirmative answer, they should go to the government authorities.
- If a physician uses the argument that Chlorine Dioxide is a toxic substance, he or she should be required to provide scientific documentation to prove it.
- If a health minister is duly informed of the existence of Chlorine Dioxide and its curative effect even without scientific evidence and ignores it, and if he or she prohibits its use by the population, he or she can be denounced to the national justice system, the Inter-American Commission on Human Rights, and the Inter-American Court of Human Rights.
- If, in addition, an official makes false statements about Chlorine Dioxide by lying to the population, he or she is violating the international human right to information, which must be truthful and timely, and can therefore be denounced to the courts. And if this leads to the death of citizens, it can become a crime of genocide.

Professor Peter C. Gøtzsche graduated as a Master of Science in biology and chemistry (1974) and as a physician (1984). He is a specialist in internal medicine; he worked with clinical trials and regulatory affairs in the drug industry (1975–1983) and at hospitals in Copenhagen (1984–1995). With about 80 others, he co-founded the Cochrane Collaboration in 1993 (the founder is Sir Iain Chalmers) and established the Nordic Cochrane Centre the same year. He became Professor of Clinical Research Design and Analysis in 2010 at the University of Copenhagen, and he has been a member of the Cochrane Governing Board twice. In 2018, he was wrongfully expelled from the Cochrane Collaboration after he published a well-founded criticism of the Human Papilloma Virus (HPV) vaccine (the vaccine is supported by the vaccine alliance GAVI). He founded the Institute for Scientific Freedom in 2019.



Below is a review of this book in the Kennedy Institute of Ethics Journal.

From the title, Deadly Medicines and Organised Crime: How Big Pharma has Corrupted Healthcare, Peter Gøtzsche makes the thesis of his book very clear. Not only does the pharmaceutical industry contribute to detrimental health outcomes through biased research, deceptive marketing, and disease mongering, but the industry's business model meets the criteria of an organized criminal operation. Gøtzsche argues for this in two parts. First, he defines organized crime by drawing upon the United States Organized Crime Control Act of 1970, the centerpiece of which is the Racketeer Influenced and Corrupt Organizations Act (RICO) (18 U.S.C. §§1961-1968). RICO prohibits deriving income from a pattern of racketeering activity, including (among other things) murder, kidnapping, robbery, bribery, extortion, and dealing in a controlled substance. Second, he argues that big pharma derives much of its income from repeated racketeering activities. He does this in part by laying out his 'hall of shame,' which is a list of cases in which large pharmaceutical companies [ie, Pfizer (US), Novartis (Switzerland), Sanofi-Aventis (France), GlaxoSmithKline (UK), AstraZeneca (UK), Roche (Switzerland), Johnson & Johnson (US), Merck (US), Eli Lilly (US), and Abbott (US)] have agreed to pay settlement fines for fraud, illegal marketing, misrepresentation of research results, and other offenses, and in part by examining various deceptive activities that are standard in the industry, including manipulation of clinical trial results, coopting of university researchers, ghost writing, and deceptive marketing. Big pharma, he argues, engages in racketeering activity so often that "there can be no doubt that its business model fulfills the criteria for organised crime". Gøtzsche is not alone in comparing the pharmaceutical industry to an organized criminal enterprise. In a striking passage, Gøtzsche quotes Peter Rost, a former Pfizer marketing vice president [who turned whistleblower when the company would not listen to his complaints about illegal marketing, as follows:

"It is scary how many similarities there are between this industry and the mob. The mob makes obscene amounts of money, as does this industry. The side effects of organized crime are killings and deaths, and the side effects are the same in this industry. The mob bribes politicians and others, and so does the drug industry."

According to Professor Gøtzsche, "[b]ribery is routine and involves large amounts of money. Almost every type of person who can affect the interests of the industry has been bribed: doctors, hospital administrators, cabinet ministers, health inspectors, customs officers, tax assessors, drug registration officials, factory inspectors, pricing officials and political parties. In Latin America, posts as ministers of health are avidly sought, as these ministers are almost invariably rich with wealth coming from the drug industry."
